

West Coast Fiber Art

September 8th – October 7th, 2017

The Escondido Arts Partnership invites West Coast regional artists to submit fiber works of art to the juried West Coast Fiber Art Exhibition. Fiber work can include paper, felt, fabric, yarn, cloth, plant, or other organic materials. 75% of the work must be fiber materials.

ELIGIBILITY

You may submit if you're a West Coast artist & your original work of art was made in the past 2 years.

ENTRY

Mail Registration Form and CD with jpg images of your work of art, including close-ups images, to 262 E. Grand Ave. Escondido, CA 92025 or email Reg. Form and images to mail@escondidoarts.org

*You may submit up to three pieces.

ENTRY FEE

EAP Member: \$20 for one, additional \$5 for each piece
Public: \$30 for one, additional \$5 for each piece

*Entry fees are non-refundable.

*Pay in person, over the phone, or mail in a check.

GENERAL PRESENTATION REQUIREMENTS

We strive to protect your work. To prevent possible damage to it, artwork must be appropriately prepared for exhibition when delivered. Artwork that fails to comply with entry requirements will be disqualified.

- 1) Two-dimensional work must be wired with sufficient gauge to support the work's weight & be ready to hang.
- 2) Installation and multiple piece works must include a simple diagram showing installation positions.
- 3) Work previously exhibited at the MG will not be accepted.
- 4) Accepted artwork may not be removed before the end of the exhibition.

If you anticipate that your work requires atypical hanging, contact the Gallery prior to delivery. Special hanging, display and/or lighting requirements will be at the discretion of the Exhibition Committee. There will be a 40% commission on works sold in the exhibition.

LIABILITY

By submitting I acknowledge that I have read and understand the general presentation requirements of the exhibition and will abide by them. The greatest possible care will be taken in handling art works. The EAP and/or their agents will not be responsible for loss or damage to any artwork submitted.

List of accepted artists and awards will be emailed & posted on our website under Exhibitions. No phone inquiries. All decisions by the juror will be final.

She volunteers helping weavers at a senior center, and travels to lecture and give workshops on sprang and doup leno.
